Determining quarantine measures for persons on the flight also depends on how close the people sat, seating positions, types of masks worn on the flight, movement of the Confirmed Case on the flight, sanitization measures during the flight, etcetera. Transmission has been variable thus far on aircrafts as there are multiple variables.	





Is it possible to get this training in email for my staff? How long should a mask be worn during the day?	The video recording of this session will be distributed within 48 hours of the session. We strongly recommend that your team attends this session; please note that for your business to receive the Healthier Safer Tourism stamp, 10% of your team needs to attend a live training session. On the chat, we have posted a number of CARPHA resources that you can share with your staff. Persons should change their masks immediately once it is wet. Persons are also expected to change their cloth masks at the end of each working day. These cannot be used the next day but washed before usage. Medical masks are not designed to be reused. They are to be appropriately disposed of as biohazard materials. Maintaining physical distancing seems to be one of our biggest issues in preventing the spread of the virus. What more can be done to ensure that people practice social distancing? Also so persons have serious facial allergies and are unable to wear masks for extended periods, any other suggestions please?	In addition to social distancing, please do handwashing with approved soaps for at least 20 seconds. In addition, persons should use appropriate hand sanitizers and ensure there is adequate use and contact time. Persons need to practice respiratory etiquette - not coughing and sneezing into their hands, coughing and sneezing into the air. Social distancing markers on the floor with easy, simple language and attractive colors. Security and staff can also be used to aid in maintaining social distancing. Persons will still be expected to wear their masks as it is a key measure to prevent/ decrease the risk of transmission. What I will suggest is that these individuals see a medical doctor to aid them in effectively identifying, managing and treating their allergies.

How effective are the "non-medical" masks?	Good afternoon. Once used effectively and with appropriate measures they are effective measures for disease control. Persons should dry off before putting on their masks. Wet masks will be ineffective in preventing the transmission of COVID-19. Your crew should continue to wear masks and ensure passengers maintain appropriate masks use and sanitization measures. As the chartered persons are from the same family, they are considered a cluster. It is advisable to disinfect before and after families are on the boat. COVID-19 can survive on different surfaces for hours to days. Disinfecting with appropriate agents will ensure you significantly decrease the risk of transmission to another family/cluster and to your crew.
I would like to know if I will be getting my stamp	If you have been regularly reporting on THiS and have met other HST Stamp measures, then you will be considered eligible for the Stamp. Please email frankmau@carpha.org if you need further clarification.

If you are referring to the team percentage requirement to receive the Healthier Safer Tourism Stamp, the requirement is 10% based on your total number of employees. Remember this is only one requirement, you must register for THiS and report for at least one month.

	COVID-19 is currently not noted as a Foodborne Disease. We recommend reducing the number of staff in the kitchen facility, to ensure frequent handwashing and sanitization and to change your masks. When working in the kitchen if using a single use masks then change every 3-4 hours. If

	Once wet, masks are to be changed immediately.
I understand the sanitizing and cleaningbut why would a cluster(family) be required to wear a mask	Because if one of them sneezes or coughs they can and will be leaving the virus on your ship's different surfaces. In addition to this, asymptomatic carriers do not show symptoms but can still spread the virus to others and contribute to fomite spread.
